

I am disgusted by the two tier policing that Toronto has recently suffered.

Pro-hamas terrorist supporters celebrating massacres, rape, baby beheadings and chanting for the extermination of Jews are handled with kid gloves. Those with a Jew-hating bent are encouraged to join in the hate rallies because it is seen as acceptable on the streets of Toronto to overtly express their hate with no consequences. I have seen them gang together to scream their vile abuse and threaten Jewish children, whilst the police in the area said they could do nothing until they physically act on their threats.

Hamas/Hezbollah/islamicjihad/PLO supporters obstruct streets, thoroughfares, block shopping malls, supermarket car parks, subway and train stations, etc. and the Toronto Police accommodate them. This is in addition to the horrific scenes with the domestic terrorist encampments taking over university campuses and physically stopping the free movement of Jews seeking to pass by and attend classes. The thuggish mobs seek to spread terror amongst the Jews of the GTA, and when the hatemongers turn up in an area in which there is a large Jewish population, the Toronto Police not only permit them to block roads and scream hate speech, they end up bringing them coffee and doughnuts. This limp and pathetic response by the Toronto Police which does not enforce laws is a disgrace that has encouraging more physical attacks on the streets, vandalism of Jewish owned stores and facilities, and of course, the shootings at Jewish schools.

Jews are now forced to obtain security for synagogues, schools, senior centres, youth clubs and community centres, etc. because Toronto Police have not, and will not, do their job. Jews have been effectively ostracized from general Canadian society because, with a few notable exceptions, most people have chosen not to associate with Jews any more because of the threat of violence to be visited upon them by those supporting terrorism.

Toronto Police Service have chosen to ignore the laws of Toronto, Ontario and Canada. If I went and started screaming abuse at someone, I would expect to be arrested. This is not only tolerated in Toronto when anti-Semites scream their lies at Jews and their children, even when done with megaphones, or when the thugs block transport infrastructure, but has been actually encouraged by the Mayor and Deputy Mayor. There seem to be few arrests, if any, when the hate driven blockages occur.

The excuse of "free speech" wears very thin when the impact on other citizens is to harass, terrorize, hinder and threaten them. Whilst pro-hamas supporters hide behind the façade of simply being anti-Israel, they are permitted to commit hate offences based on their premise that Jews do not have the right to define their own religion which includes the return to Zion (Israel) at its very core. Even if the pro-hamas mobs were not lauding terrorism, the Charter of Rights and Freedoms does not permit a party to impinge upon the rights of others who wish to enjoy security of their person. A legal right in the Charter is that everyone has the right not to be arbitrarily detained. The blocking thugs are breaching the Charter.

**Section 15 of the Charter** speaks on equality rights, that every individual is equal before and under the law and the right to equal protection and equal benefit of the law with out discrimination bases on race, national or ethnic origin, colour, religion, sex, age or physical disability. It is obvious that Jew-hating neo-nazi terrorist supporters benefit from not being held accountable under the law by Toronto Police, and that Jew inhabitants of Toronto do not benefit from equal protection.

To help the Toronto Police do their job, here is just some of the legislation available to them that could be used to rein in the hate spewing terrorist supporting hordes. Unless the laws are applied immediately to all residents of Canada, the terrorist supporters will kill people.

**Toronto Municipal Code Chapter 466** prohibits smoke bombs from use in Toronto. The maximum penalty is a fine of \$1,000. *Enforcement of this law has not happened.*

#### **Criminal Code:**

##### **Forcible entry**

**72 (1)** A person commits forcible entry when that person enters real property that is in the actual and peaceable possession of another in a manner that is likely to cause a breach of the peace or reasonable apprehension of a breach of the peace.

*Enforcement of this law has not happened.*

##### **Forcible detainer**

**72 (2)** A person commits forcible detainer when, being in actual possession of real property without colour of right, he detains it in a manner that is likely to cause a breach of the peace or reasonable apprehension of a breach of the peace, against a person who is entitled by law to possession of it.

*Enforcement of this law has not happened.*

##### **Advocating genocide**

**318 (1)** Every person who advocates or promotes genocide is guilty of an indictable offence and liable to imprisonment for a term of not more than five years. (2) In this section, genocide means any of the following acts committed with intent to destroy in whole or in part any identifiable group, namely, (a) killing members of the group; or (b) deliberately inflicting on the group conditions of life calculated to bring about its physical destruction.....(4) In this section,

identifiable group means any section of the public distinguished by colour, race, religion, national or ethnic origin, age, sex, sexual orientation, gender identity or expression, or mental or physical disability.

*Enforcement of this law has not happened.*

### **Public incitement of hatred**

319 (1) Every one who, by communicating statements in any public place, incites hatred against any identifiable group where such incitement is likely to lead to a breach of the peace is guilty of (a) an indictable offence and is liable to imprisonment for a term not exceeding two years; or (b) an offence punishable on summary conviction.

*Enforcement of this law has not happened.*

### **Wilful promotion of hatred**

(2) Every one who, by communicating statements, other than in private conversation, wilfully promotes hatred against any identifiable group is guilty of (a) an indictable offence and is liable to imprisonment for a term not exceeding two years; or (b) an offence punishable on summary conviction.

*Enforcement of this law has not happened.*

### **Wilful promotion of antisemitism**

(2.1) Everyone who, by communicating statements, other than in private conversation, wilfully promotes antisemitism by condoning, denying or downplaying the Holocaust (a) is guilty of an indictable offence and liable to imprisonment for a term not exceeding two years; or (b) is guilty of an offence punishable on summary conviction.

*Enforcement of this law has not happened.*

### **Intimidation**

**423 (1)** Every one is guilty of an indictable offence and liable to imprisonment for a term of not more than five years or is guilty of an offence punishable on summary conviction who, wrongfully and without lawful authority, for the purpose of compelling another person to abstain from doing anything that he or she has a lawful right to do, or to do anything that he or she has a lawful right to abstain from doing. (b) intimidates or attempts to intimidate that person or a relative of that person by threats that, in Canada or elsewhere, violence or other injury will be done to or punishment inflicted on him or her or a relative of his or hers, or that the property of any of them will be damaged; (g) blocks or obstructs a highway.

The maximum penalty is five years in prison. *Enforcement of this law has not happened.*

### **Mischief**

**430 (1)** Every one commits mischief who wilfully..... (c) obstructs, interrupts or interferes with the lawful use, enjoyment or operation of property; or (d) obstructs, interrupts or interferes with any person in the lawful use, enjoyment or operation of property. The maximum penalty is two years in prison, but *enforcement of this law has not happened.*

We recently saw a scared person try to get through the blocking mob and it was them who were apprehended.

I don't recall that any of the pro-hamas terrorist rallies have obtained permits for any of their riotous, threatening and vandalizing blockages.

As mentioned before, unless Toronto Police start doing their job and applying laws equally, the Jewish inhabitants of Toronto will continue to live under the threats and harassment of those who seek to terrorize and harm them. All inhabitants of Toronto are under threat of having their enjoyment of life and safe, free passage hindered at any time. Sadly, given the sickening lack of proper policing by Toronto Police, I fear it is only a matter of time until the pro-hamas terrorist supporters take their next logical step and end up murdering people. It is only by luck that the 88 year person thrown to the ground by a hamas supporter did not end up dead. Toronto Police have been warned when their failure to police Toronto fairly will lead.
