Comments/Commentaires: Hi Prime Minister Trudeau,

I'm extremely concerned that these rallies with Hamas flags keep taking place. My main concern is that at these rallies some participants are waving Hamas flags, a known terrorist group in Canada – this should not be allowed. Imagine if KKK flags were being flown or flags with Swastikas, they would likely be shut down very quicky, these rallies with Hamas

flags should be shut down and not allowed to proceed. They are pushing boundaries to see how far they can get and since they are getting away with it so far they will push farther.

Terrorist flags and terrorist speech should not be allowed and should be shut down. Why is this continuing to be allowed, it does not make sense. There is a difference between hate speech and free speech. The fact that the rally at Nathan Phillips Square on Oct 9 was allowed to take place is abhorrent.

The excuses given were 'people have a right to gather' as well as 'breaking up the rally might cause more harm than good'. These excuses are unacceptable. People gathering for hate speech flying terrorist flags should not be allowed. If I gathered with a group to plan to kill someone would that be allowed or would I be arrested for plotting murder? Hamas has it in their charter to kill off Jews, they are plotting and rallying for murder – these types of rallies have to get shut down immediately.

Further, not shutting down a rally due to it may cause more harm than good is an unacceptable excuse. Our country should have the resources to be able to stop something like this or organize to be able to get resources from other parts of Canada. Just because it's difficult does not mean it shouldn't be done.
